## Payment methods and billing

**Individuals:** bank card, cash, MobilePay (no cash payment in Huittinen, Punkalaidun, Somero and Urjala) **Other customers (companies, housing associations, etc):** bank card, cash, invoice (no cash payment in Huittinen, Punkalaidun, Somero and Urjala).

When invoicing, an invoicing fee of 6,23€ (incl. VAT 25,5%) will be added to the payment, incl. 30 €. VAT 25.5%) on invoices. A transport company importing waste is also the recipient of an invoice when importing waste from a private person.

The waste fee must be paid by the stated due date even if applied for an appeal. If the payment is not made by the deadline, annual interest on arrears must be paid on the overdue payment from the due date in accordance with section 4 of the Interest Act. Loimi-Hämeen Jättehuolto Oy will send a request for an overdue invoice, in connection with which a fee of 5€ will be charged for each payment reminder.

## Waste electronics from enterprises

Hazardous waste from companies and public institutions is subject to a fee according to a separate price list. Companies and institutions may return batches of electrical and electronic equipment free of charge in the case of items corresponding to the quality and quantity of the household. ### Information about waste reception

- The waste load to be weighed is priced on the basis of the most expensive waste type in the load.
- A weighing fee will be added to the weight-based waste fee, with the exception of useful waste grades: clean paper and cardboard (Kiimassuo and Hallavaara waste centres) and scrap metal.
- The importer of waste shall provide a written account of the waste and its origin in the form of a transfer document, as well as explanations of energy recoverability or acceptability at landfill. **A transfer document is required for the following waste:** hazardous waste, septic sludge and sealed well sludge, sludge from sand and grease separation wells, contaminated soil, construction and demolition waste (incl. concrete, bricks, demolition wood). The transfer document obligation applies to weighing and small loads of companies and organisations.
- Companies can apply for municipal waste management services for their waste through the Materiaalitori service if a market-based service is not reasonably available. The lack of service must be demonstrated by first notifying the Materiaalitori of the need for a waste management service.
- If the waste load contains something other than that stated during the inspection, a sorting fee of €188.25 (incl. VAT 25.5%) will be charged in addition to the above-mentioned waste fee.
- Industrial, construction and demolition waste loads (over 200 kg or 4 m<sup>3</sup>) and waste batches of more than 4 m<sup>3</sup> are accepted in Kiimassuo and Hallavaara.
- In Loimaa and Akaa, only waste delivered by truck containers is accepted for transfer loading.
- At the Loimaa waste station, prices determined by the City of Loimaa are used for the following waste: all soil and rock materials, stumps and other untransformed waste.

# GLOSSARY

For the purposes of this price list, the following definitions shall apply:

**Asphalt:** asphalt construction of roads and similar waste from demolition operations with a thickness of less than 100 mm.

**Concrete waste:** concrete waste which must not contain asbestos, heavy metals, PCBs or other hazardous waste.

**Biowaste:** compostable, organic, overall biodegradable waste

**Recyclable waste:** waste that municipal waste management regulations or regulations or guidelines issued pursuant to them require to be collected for recovery (e.g. glass, metal, paper, plastic and cardboard).

**Municipality's secondary responsibility (TSV):** the municipality's obligation under section 33 of the Waste Act to organise waste management when the holder of the waste requests this due to a lack of other reasonably available services and the quality and quantity of the waste is suitable for the municipal waste management system.

**Packaging waste:** recyclable waste in the form of packaging, such as plastic, glass, cardboard or metal packaging.

**End-of-life textiles:** clean, dry and odourless clothing and home textiles. The collection does not include underwear, socks, pillows, blankets, rugs, belts, bags or shoes.

**Combustible waste:** waste that is suitable for energy recovery from municipal waste that remains after sorting recyclable fractions and other materials not belonging to the eco-power plant. Combustible waste includes plastic items, cardboard and paper unsuitable

for material recovery, etc.

**Combustible pre-treatable waste:** refers to waste that, due to its large size or other characteristics, is not suitable for direct energy recovery and requires pre-treatment. Examples of this include upholstered furniture and framed windows.

**Clean cardboard:** pure and dry cardboard and cardboard waste is suitable for collection

**Clean paper:** clean and dry paper waste is suitable for collection.

**Wood waste:** boards, planks, plywood, solid wood and solid wood furniture, untreated and painted construction and demolition wood, wooden concrete forms, concrete-stained boards, fiberboard and hardboard, wooden parquet, chipboard and wood scraps, rejected products, veneer scraps, pieces of plywood. The wood may be painted, lacquered, or untreated. It may contain small metals such as nails, fittings, and hinges. Furniture must not contain cushions or textiles. The definition of wood waste does not include natural wood, i.e., for example, firewood is accepted as branches.

**Wood packaging:** wooden pallets, cable reels etc.

**Sofas, armchairs, and mattresses:** charged based on seating or sleeping capacity. A single-seater armchair will cost one price unit (€10), and a three-seater will cost three units. Mattress prices will be determined similarly according to the sleeping area.

# GLOSSARY

**For the purposes of this price list, the following definitions shall apply:**

**Data security material:** material treated and destroyed confidentially, such as archives, CDs and papers containing personal data.

**Brick waste:** clay bricks, sand-lime bricks (Kahi), lightweight concrete (Siporex, Leca blocks), masonry mortar, tiles. Brick waste may be accompanied by a screen-sized piece of concrete less than 150 mm. Brick waste must not contain asbestos, heavy metals, PCBs or other hazardous waste.

**Hazardous waste:** waste that might chemically or due to any other characteristic cause a particular hazard or harm to health or the environment.

**Municipal waste:** waste from housing or waste with similar quantity and quality from industrial, service or other activities. However, no hazardous waste, toilet waste, sewage sludge or similar waste. Municipal waste does not include soil and rocks.

**Surplus land:** in connection with excavation activities unpolluted soil and comparable material that does not contain, for example, large stumps, boulders, twigs or branches.
